KCDCC Meeting Report for Oct. 25, 2016

Rich Irwin launched into the chair's report, as there were none of the usual campaign updates by candidates or their representatives. "Keep going" was his message, as Democrats find themselves in a great position to make gains this year. He also informed us that the KC Democrats reorganization will be 12pm Sunday, Dec. 4th at the Aerospace Machinists Hall in South Park.

The first item of business was the election of a new First Vice Chair. Cat Williams, the Female KCDCC Representative from the 45th LD, was nominated and elected. She brings her experience as an events manager, and will seek to expand the donor base and to propose additional fundraising events.

Sara Franklin had proposed several days prior to the meeting that we consider rescinding our endorsement of Erin Jones, candidate for Superintendant of Public Instruction. Jones had been given donations from a backer of Tim Eyman. Upon request, Jones returned the money and Sara withdrew her proposal.

We adapted the proposed agenda for the King County Democrats reorganization, and a recommended agenda could be used for the various legislative district reorganizational meetings. There was a motion for a requirement that KCDCC officer candidates submit a written statement prior to the election, but it was defeated. Later in the meeting we voted to establish a committee to recruit candidates to assure that all offices will be filled.

Renton City Council is to be soon voting on an ordinance to ban income-based eviction of renters. This move is in reaction to recent evictions of Section 8 housing recipients at a large apartment complex in the city. We approved an emergency resolution in support.

The state legislative session begins on January 9th. The Executive Board will need to approve the legislative action agenda for 2017 at our November 22 meeting. Prior to that, the LAC committee must finalize that plan at their November 20 meeting. It will take place at the Renton Highlands Library at 2 pm. Input is requested.

We discussed our campaign donations. At the September meeting, we agreed to spend up to \$7,000 on a media buy to reach out to under-represented communities. During a telemeeting on October 16 we voted to spend an additional \$5,250 on this effort. We also voted to allow the Chair to spend up to \$5,000 on Mark Mullet's campaign, \$20.000 for Jason Ritchie (a special 21-day rule applies) and \$500 each to Kristine Reeves, Darcy Burner and Jason Ritchie. At the meeting, we agreed to add \$2,500 to the amount for Jason Ritchie, as additional money has been received.

Good of the Order announcements included a big GOTV push in the 30th LD October 29 featuring Gov. Inslee, Sen. Patty Murray and Tina Podlowoski. Mike Pellicciotti and Kristine Reeves have received the endorsement of Barak Obama.

In Case You Missed Our Last Meeting . . .

The October meeting, dubbed "Oct-VoterFest", focused on the two main events facing the 34th District Democrats. The upcoming election and the GOTV effort will be our immediate task. The future of our organization as we reorganize in January will become important as some of the officers and committee chairs making up the Executive Boards will be stepping down from their posts, and others will need to assume those roles.

In keeping with the Oktoberfest theme, we enjoyed draft beer from Big Al Brewery along with pretzels and a variety of mustards during the "Hoppy Hour". Board members circulated prior to the meeting, conversing with members and answering questions about their positions.

Once the meeting began, each board member gave a presentation of their position from the chair down to each of the standing committees. They described what tasks were expected of them, and how they preformed their duties. Marcee encouraged members to consider volunteering for a role in the organization.

Senator Sharon Nelson and Representative Joe Fitzgibbon (pictured at right) gave us a run-down of the status of legislative races around the state. Sharon is leading the State Senate Campaign Committee to re-take the state senate. We will need 2 seats and there are 5 in play. The average cost of a state senate race is 1 million dollars. She urged us to make calls to help retake the senate. Joe is in charge of the equivalent state house effort. He feels that there are 12 seats we could pick up this year.

One note of concern is that money isn't going to the Trump campaign and is being funneled into local legislative races instead. A point of which we can take pride in: Out of all the LDs, the 34th District has contributed the most funds. Later in the meeting we approved a motion to donate an additional \$3,000, to be split between the two campaign committees.

Tom Rasmussen talked about what PCOs do and why they are so important. He discussed the benefits of walking a precinct and relayed his recent canvassing experiences door belling for state senate and house candidates in other LDs.



Drew Estep, our coordinated campaign field worker, laid out our district's GOTV strategy and had lists for PCOs and walk literature, including our Sample Ballot.

We also added to our list of endorsements by endorsing the Highline School Bond, Proposition 1. Joe Fitzgibbon asked us to endorse I-1501 to stop fraud and protect seniors. The body voted for a YES position.

Resolution to Support the Coalition to Build 1000 Homes

WHEREAS the 2016 One Night Count by the Seattle/King County Coalition on Homelessness found 4,505 people living on the streets; and

WHEREAS the crisis of homelessness has gotten so bad that the City of Seattle has declared a State of Emergency on Homelessness; and

WHEREAS working people are being priced out and forced into increasingly precarious economic circumstances; and

WHEREAS Seattle rents have gone up at more than three times the national rate, with rent for the average two-bedroom apartment at nearly \$2400/month; and

WHEREAS the profiteering of big developers is driving working people, students, people of color, and immigrants out of our city; and

WHEREAS, with the shelving of plans for a new police precinct building, the City now has available bonding capacity and cash to fully fund the construction of 1000 units of affordable housing, the majority of which will be accessible to the families most vulnerable to homelessness; and

WHEREAS an Office of Housing Affordability Covenant could guarantee that six out of seven of the 1,000 affordable homes would be rented to a person or family making 0-30% area median income (AMI) and one out of seven would go to a person making 0-60% AMI, ensuring that the communities who are among the hardest hit by the affordable housing crisis, communities of color in particular, will benefit the most from funding;

THEREFORE BE RESOLVED that the 34th Legislative District Democrats support the Seattle Human Services Coalition, the Seattle King County NAACP, Church Council of Greater Seattle, Latino Advocacy, El Comité, Tenants Union of Washington State, Seattle Indian Center, Transit Riders Union, Washington CAN!, Got Green, Real Change, Nickelsville, SHARE, Steps Housing, Justice Works, Upgrade Seattle, Faith Action Network, Socialist Students, in addition to hundreds of ordinary working people in Seattle, in support of the Coalition to Build 1,000 Homes.

THEREFORE BE IT FINALLY RESOLVED that the 34th Legislative District Democrats send copies of this resolution to the Seattle City Council members and Mayor Ed Murray.
