Renewing members who are NOT PCOs must pay 2017 membership dues in order to vote - you can do so online here or at the meeting. Proxy voting is not allowed.



Resolution in Opposition to Medicare Privatization

WHEREAS the establishment of Medicare in 1965 provided health insurance to everyone over 65, half of whom had no health insurance of any kind; and

WHEREAS all programs benefitting the public will be under massive attack in 2017 with the control by Republicans of both houses of Congress and the presidency; and

WHEREAS Representative Paul Ryan of Wisconsin has already proposed legislation that will eliminate Medicare and replace it with vouchers to be applied to private insurance policies (CouponCare); and

WHEREAS age-rated policies are inevitably disastrously expensive, particularly for those older people who are in poorer health; and

WHEREAS the Congressional Budget Office evaluated the cost to seniors of privatizing Medicare in 2011 and estimated that health care costs for beneficiaries would be doubled at minimum;

THEREFORE BE IT RESOLVED that the 34th Legislative District Democrats demand that our entire Congressional delegation oppose Medicare privatization with no compromises; and

THEREFORE BE IT FINALLY RESOLVED that the 34th Legislative District Democrats send copies of this resolution to our senators and to all Congressional representatives in Washington State.

Seattle "Democracy Vouchers" Coming Soon

Last year Seattle voters approved the initiative I-122 titled "Honest Elections Seattle". Funded by a modest property tax, it limits election campaign contributions from entities receiving City contracts totaling \$250,000 or more, or from persons spending \$5,000 or more for lobbying. It also requires paid signature gatherer identification. In addition it limits lobbying by former City officials.

I-122 also creates a voluntary program for public campaign financing through \$100 allotments called "Democracy Vouchers". Registered voters in Seattle will receive four \$25 vouchers that can be assigned for the use of any qualified candidate for Seattle City office. In 2017 the office-seekers for City Council and City Attorney are eligible to apply for this new public financing method. In 2021 this program will be expanded to include Mayoral candidates.

These vouchers will be valid until November 30, 2017. They may not be transferred to another voter either by sale or gifting and they have no monetary value except to the qualified candidate(s) of your choice. So keep involved with this year's election and use this opportunity to participate in this new means of public financing of our city elections.

All registered voters will automatically receive vouchers in the mail beginning January 3.






Thanks to our Faithful 7th Congressional Elector, Chris Porter

Build our membership


