## **KCDCC Meeting Notes - June 26, 2018**

The meeting was called to order at about 7:15 by Chair Natalie Reber. After some housekeeping, the first order of business was endorsements.

The Endorsement Committee provided no recommendation for US Senate. I did not hear a reason. I intended to ask for clarification at the end but got distracted and missed my chance.

The Endorsement Committee produced a slate of 5 judges recommended for endorsement, and recommended Dan Satterberg for KC Prosecutor. Satterberg was pulled from the slate and the judges were endorsed.

Satterberg was moved separately and failed. Daron Morris was moved for KC Prosecutor and got 60%. With 2/3 required, so he failed too.

A slate of legislators was moved by the committee, including Joe Fitzgibbon. It was passed.

They then took on two races that the Endorsement Committee recommended endorsing candidates counter to the LDs endorsement. This included House position 2 in the 48<sup>th</sup> and the Senate in the 34<sup>th</sup>. In the 48<sup>th</sup> Pos 2, we endorsed the candidate endorsed by the LD, Cindi Bright, and did not endorse the candidate recommended by the committee.

For the 34<sup>th</sup> Senate race, the committee recommended Sofia Aragon. Chair of the 34<sup>th</sup>, David Ginsburg, spoke about our process and how we ended up with a duel endorsement for Joe Nguyen and Shannon Braddock and moved that we endorse both. This was approved. The committee then moved their recommended candidate and that failed 6-36.

That concluded the endorsements. For details on who was endorsed please refer to the KCDCC web site.

We had a financial report. We don't have much money but we are free from the office lease. The settlement with the Attorney General's office for previous PDC reporting violations will be finalized Friday 6/29 and we will have a report at the next meeting, which will be done in executive session. We will have a revised budget presented next meeting for approval.

We will hire a company, Argo Strategies, to handle our PDC compliance needs due to the resignation of our treasurer 10 days prior, and we approved a \$300 expenditure to pay for the July reporting.

## In Case You Missed Our May Meeting...

The June endorsement meeting started off with the Chair's Report by **David Ginsberg**. A concern he has is that with seven Democratic candidates running to replace Sharon Nelson's State Senate seat, there is stands the possibility that the 33% of 34th's voters identifying as Democrats could split the vote, and sending two Republican candidates on the general election ballot. People look to our endorsements for guidance, and we must make sure that is put out to the public before they vote. Sharon is leaving "big shoes to fill". He also urged us to get tickets to the July 19th Garden Party.

**Dale Bright,** Political Director for the Laborers Local 242 was on had to present us with a check for \$2,500.

Our representatives to the King County Democrats told us of the election of a new chair of that organization, **Natalie Reber**. They also informed us that they were now free of the lease office in Auburn. In a bit of irony, the space is now housing the Dino Rossi campaign for the Eighth District.

Endorsements began with a slate of non-controversial, previously endorsed candidates without Democratic primary challengers. This was passed by a vote of credentials.

Those seeking endorsement for the State Senate included Sofia Aragon, Lois Schipper, Joe Nguyen, Shannon Braddock and Lem Charleston. Another Democratic candidate, Annabel Quintero, was also present, but since she had not filled out the King County Democrats' questionnaire (a requirement for consideration) she was not allowed to seek our endorsement. She later introduced herself to the body.

Aragon spoke for herself. She is concerned about affordable-housing. She is a board member of the Washington Low Income Housing Alliance. She also wants to see everyone has access to higher education. She is a nurse and a lawyer and has been advocating for universal healthcare for a decade. Schipper wishes to put "families and chil-



dren first" by fighting homelessness and hunger, fully funding education and working for gun safety that would include a assault weapons ban.

Nguyen wants all families to have the opportunity to achieve the American dream and stressed "health care for all" – he relayed a family story of a crash that left his father a

quadriplegic. **Brooks Salazar** spoke for **Braddock**, who then later spoke for herself. She pointed to her experience as a working single mom, a board member of several community groups and her work with Joe McDermott on the King County Council. She proclaimed that she would be "ready on day one". **Charleston** directed us to his having been in the US Marine Corps, a pastor, and as a police chaplain. He sees "millionaires on the beach" unhappy with high property taxes, and people on sleeping on the street "you know their not happy" He wants to bring his passion to help address the district's problems.

The first ballot found Braddock on top with 57 votes but short of the 60% for a sole endorsement. Nguyen was second with 39. The second voting round resulted in a 62-62 vote tie and a dual endorsement.

Also endorsed was the signature gathering for three initiatives. I-1631 was presented by **Ann Martin**. It would impose a carbon emissions fee on businesses and use the proceeds to fund air quality and green energy programs, water quality and forest health projects. I-1644 would overturn Tim Eyman's 1998

initiative I-200, and restore affirmative action in Washington's state code. Bunny Hatcher presented I-1639, an initiative that would enact measures related to gun safety.

**Daron Morris** was put forth for endorsement for King County Prosecutor and introduced himself. **Dow Constantine** rose to speak on behalf of incumbent Dan Satterberg, who has recently switched his party preference to Democrat. Dow said that move now allows him to support Satterberg. Dow feels he is doing a good job in transforming our county's justice system and we should not endorse his opposition. There was another speaker for Satterberg, and a speaker against. The endorsement for this office was tabled, with hope that both candidates could come to the July meeting to speak to their qualifications.

Southwest Sewer District Commissioner **Bill Tracy** was proud to announce that they will be officially opening their new facility in on June 26 in Burien located at 17840 Des Moines Memorial Drive South. He also announced that the White Center Kiwanis Pancake Breakfast fundraiser will be Saturday, July 21 at the White Center Eagles, a new venue this year.

There were over 500 delegates in total attending, including those elected in their respective LD caucuses and state committee members, LD chairs and Democratic elected officials, who were automatic delegates to the convention.

## In Remembrance - Former 34th LD Representative - Paul F. Pruitt, 1922 - 2018

Former 34th Legislative District Representative, Paul Pruitt, 1977 to 1985, passed away earlier this month on July 2nd.

Pruitt was born in 1922, in Shelton, Nebraska, and grew up in Nebraska, Idaho, and Washington. He graduated from Kirkland High school and attended the College of Puget Sound and then on to Yale Divinity School. He was an ordained minister in the United Church of Christ for many years.


Pruitt was active in the Tacoma area civil rights movement in the 1960's, and helped start up the Seattle food bank programs. He served on the King County Board of Ethics. He was also active in the Church Council of Greater Seattle, WA Assoc. of Churches, Health Care For All-Washington Board, and Fellowship of Reconciliation.

Pruitt is survived by his wife of 69 years, Mary, and a large group of family members.


