Notes From the February 25th KCDCC Meeting

Elections were held for an officer position and Standing Committee chairs. Jessica Agi was elected 4th Vice Chair, Scott Forbes was elected to the Rules Committee, Amber King to the Platform Committee and Nathanial Block to Credentials.

In her Chair's Report Shasti Conrad emphasized importance of the March 10th primary and asked all attendees to continue to educate others about the Primary/Caucus process. She reiterated the importance of sticking together once primary process is completed and that we must treat one another with respect, so that coming together is easier for the November General Election. She thanked everyone for all their work to take the country back and to ensure people at every level have access to their government. She also noted that the state party will provide presentation with LDs on caucus process when asked.

Bylaws and Rules Committee reported that they will be putting forward recommendations for changes next month, mostly basic maintenance at the re-

quest of the finance committee. They are also exploring ways to facilitate voting by email.



Activities for PCO Recruitment, Training and Outreach include start to track PCO recruitment with a goal of filling every seat. Every PCO chair has been given a list of existing cohort and asked for all LDs to review the list and ensure that all paperwork etc. per state law is in order. There is push towards the May filing deadline. Turning out the vote in August and November requires more PCO seats filled It was noted that a precinct with a PCO typically has turnout that is 5 points higher than those without.

The Platform committee has been convened. It consists of 4 regional representatives and 6 community representatives with alternates and is working toward a presentation at the May 2nd King County Convention - which will be dedicated wholly to the platform construction process.

In Case You Missed Our Last Meeting...

The meeting program, "Eyes of Immigration", was organized by our Treasurer Ben Reilly, who brought together a panel of legal and activist experts on immigration and deportation.

Present were **Rich Stolz** of OneAmerica, **Joanne Kalas** of Foster Garvey PC, **Louise Bush** from the Seattle Clemency Project, **Maria Kolby-Wolfe** of NWIRP (NW Immigrant Rights Project) and **Bunthay Cheam** of the Khmer Anti-Deportation Advocacy Group. They provided updates on the immigration and refugee crisis in Washington and beyond. Discussion points included highlighting the Trump administration's tactics for punishing immigrants, the deportations that are happening in our own communities, and state legislation aimed at stopping the targeting of our immigrant communities.

The panelists have complementary roles, and work is done between the various agencies they represent to see that immigrants on the verge of deportation get adequate representation in an over-crowded appeal system...the Trump Administration has not appointed any new immigration judges. Unlike our traditional court system, immigrants are not automatically entitled to legal counsel.

Bush is a pardon manager. She works to get reformed prisoners, including immigrants, pardons through the Washington State Clemency Board. This body consists of 5 members and only meets 4 times a year, creating a frustrating

bureaucratic bottleneck. Experience with that system puts the Seattle Clemency Project in a position to work with immigrants about to be deported. to get gubernatorial pardons for past, often minor, crimes for people that have redeemed themselves. The pardon process is like the clemency process, and the same board is used. Once pardoned, the immigrant can go in front of an immigration judge to plead their status.

Kolby-Wolf provides legal representation for immigrants. NWIRP worked on 10,000 cases in this state in 2019. They are seeing more demand for their services due to increases in residency/refugee requirements, with confusing and ever-changing forms. Private prisons are making a lot of money housing immigrants from the federal government...taxpayer money better spent.

Cheam is Cambodian, was born in a refugee camp in Thailand, grew up in our district. White Center is one of the largest concentrations of Cambodians in the Northwest. Laws passed in the 1990s to get tough on crime created a school-to-prison pipeline. Kids get in trouble, often for petty offences, and that later can negatively affect their immigration status as adults...often leading to deportation back to homelands with cultures that are completely alien to them.

Stoltz is from OneAmerica, the largest immigrant and refugee advocacy organization in Washington State. He is involved in monitoring and advocating legislation a local, state and national levels. He relayed story of a Cambodian adoptee whose parents failed to get him nationalized and found himself dropped into undocumented status as an adult.

Kalas is an environmental lawyer, who does volunteer immigration legal counsel, which she calls her "Superhero Pro Bono Work". She described two cases involving Southeast Asian men brought here as children who got into legal trouble. One is Cambodian and was scheduled to be deported before having his case taken up, and eventually pardoned. The other is Vietnamese and is currently going through the pardon appeal process.

Later we took up the Code of Conduct once again. **Chris Porter** presented a draft of a new version. The question put

to us is whether to adopt the new version, or keep our original document. Les Treall asked us to consider his objections to the new Code. We discussed the issue at our tables and reported mixed opinions to the larger group. We agreed to a new Code of Conduct, but we will revisit it again at the March meeting to incorporate changes.

Resolution Defending Immigrant Rights

WHEREAS the Trump Administration's immigration enforcement policies are restrictionist, prioritizing deportation of legal immigrants, restriction of the visa process, and rejection of asylum claims; and

WHEREAS the Trump Administration's designs its immigration enforcement policies to intimidate immigrants and deter immigration through fear, pain, suffering, and trauma – making them cruel by definition; and

WHEREAS these policies permit arrests in courthouses and the State Clemency Board, effectively excluding immigrants from participating in our justice system and public life; and

WHEREAS the executive branch, having authority over US immigration courts, has been allowed to deny due process and hold people indefinitely without charges or bail; and

WHEREAS when arrested, immigrants face extensive detention without access to legal representation and separation of children from their parents; and

WHEREAS these policies damage communities and tear apart American families – frequently target documented, law-abiding immigrants and refugees; and

WHEREAS life-long American residents are deported to countries they have never known and often do not speak the language; and

WHEREAS interacting with the court system is one of the only methods of relief for immigrants targeted by the Trump Administration; and

WHEREAS applying for clemency is one of the only methods of relief for immigrants charged with crimes targeted by the Trump Administration; and

WHEREAS the Trump Administration's intimidating tactics and Washington's overloaded State Clemency Board are insurmountable obstacles for our immigrant communities; and

WHEREAS Washington's House Bill 2567 and its companion Senate Bill 6522, Courts Open to All Act, would prohibit civil arrests inside or near state courts, prohibit inquiries into or collection of immigration or citizenship status information, prohibit disclosure of nonpublic personal information about individuals to immigration authorities, and establish processes in the event of law enforcement action at court facilities; and

WHEREAS the US House Resolution 5383, New Way Forward Act, would end mandatory immigration detention, end automatic deportation and summary proceedings for people who have had contact with the criminal legal system, end local police engagement in immigration enforcement and over-policing of communities of color, and decriminalize illegal entry and reentry into the US; and

WHEREAS expansion of the Washington State Clemency Board would improve relief for Washington's immigrant communities and increase assistance for those people facing deportation;

NOW, THEREFORE, BE IT RESOLVED THAT THE 34TH DEMOCRATS:

- Reaffirm our support for immigrant communities; and
- Call on the Washington Legislature to pass the Courts Open to All Act, defending the rights of immigrants to freely access our justice system; and
- Call on the US House of Representatives to pass the New Way Forward Act; and
- Call on the US Senate to turn away from the injustices imposed by the current administration, support and pass the New Way Forward Act; and
- Call on our Governor to expand the Washington State Clemency Board to improve assistance for Washington's immigrants who have had contact with the criminal justice system.

Resolution in Support of Washington Democrats' Commitment to Israeli-Palestinian Peace, and in Opposition to any Further Occupation, Settlement Expansion, or Other Unilateral Annexation of West Bank Territory

WHEREAS the Washington Democratic Party's 2018 platform rightly states support for serious negotiations between Israel and Palestine in order to evolve a solution that would include a sovereign state of Palestine and a sovereign state of Israel; and

WHEREAS the Trump administration has upended decades of bipartisan support for such a two-state solution, and the Israeli government has accelerated settlement expansion and implemented several steps toward annexation of much of the West Bank, seriously threatening a peaceful two-state solution; and

WHEREAS the U.S. State Department issued an opinion in 1978, defining Israeli settlements in the West Bank as illegal under the Fourth Geneva Convention – an official position in effect for over 40 years, until reversed by the Trump administration on November 18, 2019; and

WHEREAS, in response to the above reversal by the Trump administration, 106 members of Congress wrote to Secretary of State Mike Pompeo on November 21, 2019, expressing their vehement opposition to the State Department's decision to consider Israeli settlements legal – a decision that greenlights further annexations and threatens any genuine two-state solution; and

WHEREAS the U.S. House of Representatives, on December 6, 2019 – with 192 cosponsors, including all seven Washington Democrats – adopted H. Res. 326, expressly supporting a two-state solution and opposing settlement expansion, drawing a red line against unilateral annexation of West Bank territory and declaring that such roadblocks to a peace agreement "pose a threat to the ability to maintain a Jewish and democratic state of Israel and [to] the establishment of a viable, democratic Palestinian state"; and

WHEREAS Rep. Pramila Jayapal (WA-7) has endorsed J Street U's #ChangeThePlatform campaign to add to the Democratic Party's national platform a statement of opposition to the Israeli occupation, illegal settlements, and annexation, calling such a statement "essential";

THEREFORE, **BE IT RESOLVED** that we support the right of both Israelis and Palestinians to govern themselves, each in their own viable state, and we oppose any further occupation of Palestinian territory in the West Bank or Gaza, whether by settlement expansion or unilateral annexation; and

BE IT FURTHER RESOLVED that we support adding to the national Democratic platform a statement opposing occupation, settlement construction, annexation, and demolitions of Palestinian communities in the West Bank; and

BE IT FURTHER RESOLVED that this resolution be sent to the Chair and Co-Chair of the Democratic National Committee, our state's members of the DNC, and Washington's Democratic Party Chair.
