# In Case You Missed Our January Meeting...

The January reorganization meeting began with newly elected head of the King County Democrats, Chair **Shasti Conrad**, serving as our temporary chair. 78 PCOs were elected in the August primary and those that were in attendance were eligible to vote for a new roster of district officers to serve for the next 2 years. All members were able to vote for the positions of Secretary and Treasurer.

Three members were nominated to stand for Chair: **Gina Topp**, **Rachel Glass** and **Ivan Weiss**, who had previously served two terms in that role from 2005-2008. Gina Topp prevailed with 52.8 percent of the vote and presided over the rest of the meeting.

The vote for 1st Vice Chair followed. **Rachel Glass** was elected over our outgoing Chair David Ginsberg.

The rest of the officer positions were uncontested and were elected via acclamation in turn:

2nd Vice Chair – **Sophia Aragon** State Committee Persons – **Chris Porter** and **Ann Martin** KCDCC Committee Persons – **Max Brown** and

KCDCC Alternates – **Ted Barker** and **Martha Koester** Secretary – **Carla Rogers** Treasurer – **Ben Reilly** 

Ann Martin stated that she was happy to again fill the role of representing us at the state party, but would look to mentor one younger to assume the position if a person came forth and expressed an interest for taking on the job next term.

As we waited for the votes to be counted, we heard from our new State Senator, **Joe Nguyen**, who returned home after

spending the day at work in Olympia with the Democratic Caucus, forgoing a dinner with Governor Inslee. He praised former Senator Nelson's "big shoes". He's been appointed to Environment, Energy & Technology, and Transportation committees. He is also the only freshman on the rules committee. Joe is also now the Vice Chair of the Human Services - Reentry & Rehabilitation Committee.

He hopes to see a less regressive tax structure implemented. A capital gains tax is high on his list. He is configuring his office space in such a manner to better facilitate outreach to the public schools and

other organizations through video conferencing. He and his staff will be actively using social media to increase transparency. He announced a 34th district town hall meeting that was held January 12.

We also heard from Rep. **Joe Fitzgibbon** who spoke on the work to reduce climate change, and to the efforts being made to protect the orcas of Puget Sound. He also expressed pleasure in the successes Democrats achieved in the November elections and our increased strength in the House.

**Rep. Eileen Cody** rose to share with us that the day of the meeting was her last day of work at Kaiser, and was looking forward to her retirement as she celebrated with a glass of wine.

Marcee Stone-Vekich asked us to endorse Seattle Schools Propositions 1 and 2, as well as a proposed merger of 2 King County Water districts. We had previously voted in favor of the school propositions, but we reaffirmed our support, as well as water district measure.

Chris Porter will be running for King County Conservation District Supervisor. Those wishing to vote must request a ballot. The voting period will be from Monday, March 18, 2019 at 9:00am through Friday March 29, 2019 until 5:00pm. All ballots must be requested by the end of the voting period to be valid. Because this is an on-request mail-in election, no "absentee ballots" are necessary. #### **Treasurer's Report**

Balance \$12,047k, Debt \$19,770. Debt due to filing issues last year that led to fines. Payments already scheduled to resolve debt over the next two years. In 2018, much less money was raised than in years past. That said, 2019 starting well with \$15k pledges and \$5k of that already collected.

#### Resolutions

Approved: Resolution in Opposition of a New Hot Mix Asphalt Facility on Renton – Maple Valley Road within 150 feet of the Cedar River.

<u>Approved:</u> Amendment to Section 6.3 of the Bylaws recommended by PCOs to move to 15% threshold for quorum. 15% = 153 elected PCOs (this number could change with appointed PCOs).

#### **New Appointment**

Roger Ledbetter appointed as Ombudsman. He will work to mediate conflict and help make meetings run more smoothly, help to connect the dots and make recommendations to Eboard, facilitate mediation, and establish ground rules for conducting meeting/ making a safe space. # I-1000 Sets Record for Initiative Signature Submissions



According to the Secretary of State's office, I-1000 submitted the largest number of signatures for an initiative to the Legislature in state history when the Yes on I-1000 initiative campaign turned in petitions with over 387,000 on January 4, 2019. 259,622 would be required for qualification to be sent to the Washington State Legislature for consideration.

The ONE WASHINGTON EQUALITY CAMPAIGN is a statewide movement for Diversity, Equity & Inclusion in public education, jobs and government contracting for qualified women, veterans, persons with disabilities and people of color.

I-1000 will repeal Tim Eyman's 1998 I-200 that bans affirmative action. Washington state is currently one of only 8 states in the country with such a restriction.

# State Committee Meeting Report, Held In Olympia, January 27-27, 2019

The Reorganization Meeting of the Washington State Democratic Party was held January 25 through January 27, 2019 in Olympia. The reorganization involves among other things the election of officers for the State party. Tina Podlodowski was re-elected as chair; David Green of Spokane was elected vice-chair; Rob Dolin was re-elected as secretary; and Habib Habib was re-elected as Treasurer. There also was an election for congressional district representatives who serve on the executive committee of the State party. Representative Javier Valdez was re-elected; he indicated this would be his last term and that he would be glad to mentor someone as his replacement. These elections occurred on Sunday morning.

The previous days were filled with meetings, training sessions and the annual Maggie Awards ceremony/ dinner. Rep. Monica Stonier and King County Executive Dow Constantine spoke and helped present the awards on Friday night! Other elected officials present included Senator Sam Hunt and Bob Hasegawa, WASHINGTON STATE DEMOCRATS

Representatives Sharon Tomiko

Santos, Brian Blake and Javier Valder, and Insurance Commissioner Mike Kreidler! The awards went to the following individuals:

In other significant actions, action on amendments to the rules related to the status of constituency caucuses was postponed until the September meeting to allow added time for discussion between the Rules Committee and constituency caucus representatives. This is a largely internally significant matter.

The heavy lift of work that will shape our nomination process in 2020 will happen over the next few months. The 2020 Delegate Allocation and Affirmative Action Plan, which needs to be drafted by the April Central Committee meeting in Pasco in order to be acted on by the National Democratic Central Committee is the focus of that work. The State plan will likely include some sort

of primary/caucus model, although there are competing proposals that would still involve our historical caucus model. Not only must the state committee decide what direction to go, but how to implement such a process. Stay tuned for more on this.

The Resolution and Rules committees met on Friday afternoon. Constituency caucus meetings were scattered throughout the weekend starting on Friday afternoon and ending on Sunday afternoon. Much of Saturday was taken up with orientation for members, training and other discussion including the primary/caucus topic described above. Leonard Forsman of the Suquamish Tribe led a session on Tribal Relations and Tribal Sovereignty Training over the lunch hour on Saturday. The state highlighted its "Rise and Run" theme for the next two years (and beyond) to encourage Democrats to

get the skills and take the plunge into electoral waters from the lowest local to the highest national offices. The state will be working to identify Democrats who are interested in running for both partisan and nonpartisan offices and helping them by connecting

them with local party organizations and developing tools to help them succeed.

Sunday's general session included not only the election of officers, but DNC reports and voting on resolutions. Resolutions deal with current legislation. Those passed included ones dealing with tax returns of presidential candidates (HR 1 and SB 5078), rent controls and other tenant-related regulations (HB 1493), Native American Voting Rights (addressing, SB 5079), expanding voting rights for persons in "community custody" (SB 5076), universal health care (SB 5222), restoration of affirmative action (Initiative 1000 – a to the legislature), dental therapy provider, reimbursement fairness for counties (HB 1481 and SB 5500) and missing and murdered indigenous peoples (HB 1713). A resolution on instant runoff voting was tabled because there is no legislation pending; the chair's decision was challenged and upheld.

Ann attended the Rules Committee and Women Federation meetings as well as constituency caucuses including the Women's Caucus and the Environmental and Climate Change Caucus.

Chris led the Affirmative Action Committee and attended the Rules Committee.
